**6. Photo Requests:** Prior to or during the wedding, the client or guests may inform the photographer of subjects which they would like photographed, but the final content of the images is at the discretion of the photographer.

**7. Displaying Images:** When using digital photography, the photographer(s) will be under no obligation to display the images while the event is still underway.

**8. DVD Photos:** The photographer will provide, at full resolution, all images on DVD.

**9. Unlimited Usage Licence:** The client is granted an unlimited usage licence to use the images for personal use. Images may be reproduced freely in print and digital form. When using the photos online, the photographer asks that a link is present to the photographer's website <http://www.shackletonphoto.co.uk>. No derivative works may be made from the images without the photographer's consent. The client may not assign or transfer the unlimited usage licence.

**10. Other Usage:** The client must negotiate additional payment with the photographer if they wish to use the images in any other manner.

**11. Unlikely Emergencies:** In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. "The photographer will make every effort to secure a replacement able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received.

**12. Back Up:** The photographer will aim to maintain backup copies of the images in his archive for a period of 3 years.

**13. Deposit:** A deposit of £350.00 is due from the client to photographer at the signing of this agreement to secure the date. The remainder of the photographer's fee is payable before the wedding day.
